# Haryana quota law could hit 150K IT jobs: Nasscom

### NEHA ALAWADHI New Delhi, 15 March

he Haryana government's recent law mandating 75 per cent reservation for locals in private jobs with a monthly salary cap of ₹50,000 will impact about 150,000 information technology jobs in the state. This was found during a survey by the National Association of Software and Services Companies (Nasscom).

As many as 80 per cent of the respondent companies said this will negatively impact their future business operations and investments plans. The majority of them said this will result in shifting out of Harvana or growing operations in other states and other countries.

The survey saw responses from 73 of the 500 IT/ITeS companies in Haryana that employ more than 4,00,000 directly.

"Extrapolating to 400,000 IT-ITeS employees, the Act will impact about 150,000 jobs (37 per cent of all IT/ITeS jobs). Given that the Act applies to new hires, the impact is expected to be severe in 1-2 years as the industry sees high attrition," Nasscom said.

This means that within the next one to two years, if a sub ₹50,000 salary employee working with a firm in Harvana were to guit and go to another firm, the company would have to hire a local. The survey found that 81 per cent of employees at the respondent firms were from outside Haryana, and 44 per

# Kotak, Allianz in tie-up for private credit

Kotak Investment Advisors (KIAL), the fund manager of Kotak Mahindra Group and Allianz Investment Management - the investment management arm of Germany's Allianz Group — said on Monday that they have tied up to invest in India's private credit market.

In February 2021, Allianz made its maiden investmen of \$150 million in KIAL's 11th real estate debt fund that achieved a closure of \$380 million. 
