SUMMARY OF THE PROCEEDINGS OF THE 34TH ANNUAL GENERAL MEETING OF D S KULKARNI DEVELOPERS LIMITED ('THE COMPANY'):

(IST), at Unit No. 301, 3rd Floor, Swojas One, Kothrud, Pune 411038 through physical mode in accordance with the applicable provisions of Companies Act, 2013 read with the Rules made thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, and also in terms of the circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India, from time to time in this regard to transact the business as set out in the Notice of the AGM dated 3rd September, 2025 and addendum to Notice of AGM dated 22nd September 2025.

The Meeting commenced at 03:00 P.M. (IST) and concluded at 03:30 P.M. (IST).
